

How much does the pretrial population contribute to overall citywide docketed arrests?

Most docketed arrests citywide are of people who do NOT already have another pending case (76% in March 2021, down from 81% in 2019 as arrests among the non-pretrial population plummeted in 2020). Pretrial rearrests make up a smaller proportion of total docketed arrests.



Of all docketed arrests in March 2021, only about 5% already had a pending VFO case at the time of their new arrest. Another 5% had a pending NVF, and 13% had a pending misdemeanor (because there were more than 30,000 people in the community pretrial on a misdemeanor in March, though less than 4% of those were rearrested that month).





Of all docketed VFO arrests citywide in March 2021, only about 7% had a pending VFO case. Another 4% had a pending NVF, and 13% had a pending misdemeanor. (Pandemic court delays have caused an increase in the number of people in the community on pretrial release for a VFO—but of the almost 10,000 people in March with a pending VFO, only 1% were rearrested for a new VFO that month.)


All Citywide Docketed VFO Arrests Each Month: Type of Pending Case



Pending Case Type












Of the ~3-5% who are rearrested each month, most new arrests are for misdemeanors or non-violent felonies.

NOTE: Rates cannot be compared between different pretrial statuses, as these analyses do not control for baseline differences in types of cases and different journeys through the pretrial period—e.g. people on SR are more likely to be younger, have another pending case at the outset, and have substantially longer pretrial periods than other pretrial statuses. Different percentages of each group are also incarcerated at times during their pretrial period (and thus not in the community), as pretrial status is defined as status at first release on the case.

A new arrested is counted only when a charge is filed with the court.

A person on pretrial release can be tracked for a single case for up to 365 days. As a person can have mulitple pending cases, a person may be tracked for greater than 356 days in total.


How does the pretrial population awaiting resolution of a <u>VFO</u> charge fare each month, in terms of rearrest?

Of the~10,000 people who were awaiting resolution of their <u>VFO</u> case in the community in March, 96% were not rearrested at all that month, and 99% were not rearrested on a new VFO. This has remained relatively stable over time.








Most people awaiting their case resolution for their <u>VFO</u> case in the community each month are not rearrested that month regardless of the pretrial conditions under which they are waiting. In March, of the VFO pretrial population in the community:

- The vast majority of people in all pretrial release categories were not rearrested at all
- 99% of people in all pretrial release categories were not rearrested for a new VFO




Of the ~5-7% of the <u>VFO</u> pretrial population in the community who are rearrested each month, rearrests are distributed across crime types. Rearrests most often occur among those who are ROR'd (though the rate of VFO rearrest among this population is very low as the vast majority of ROR'd people awaiting their VFO case in the community each month are not rearrested).





The most common VFO rearrest pattern among people in the community with a pending VFO is repeat burglary. For the most part, people in other VFO categories are not docketed for repeat behavior rearrests at high rates.
