

How many people with open criminal cases are re-arrested?

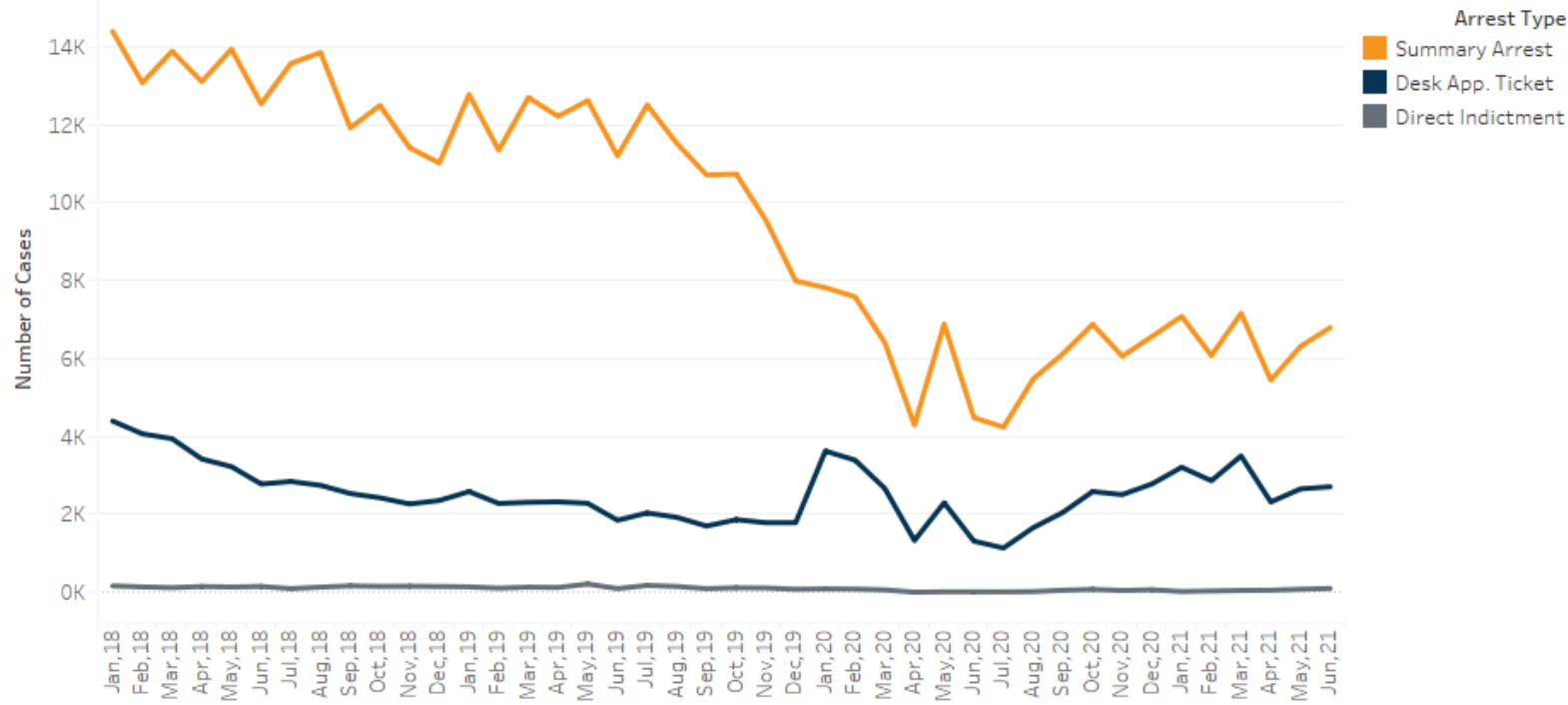
January-June 2021 Toplines

- Fewer people are being arrested, and a smaller number of those arrested have an open criminal case. (p.9)
 - Most pending cases are misdemeanors.
 - On average, fewer than 500 people each month were rearrested for a violent felony offense, out of over 9,000 arrests.
- Of the approximately 1,300 people arrested each month for a violent felony offense, around 100 had an open violent felony case. An average of 9,800 people charged with a violent felony are awaiting case resolution in the community each month. (p.11)
- The majority of the pretrial population is not rearrested. Pretrial rearrests have remained consistent over time and have not changed with bail reform. Fewer than 1% of the 45,000-50,000 people out pretrial are arrested for nonviolent or violent felonies each month. (p.22)

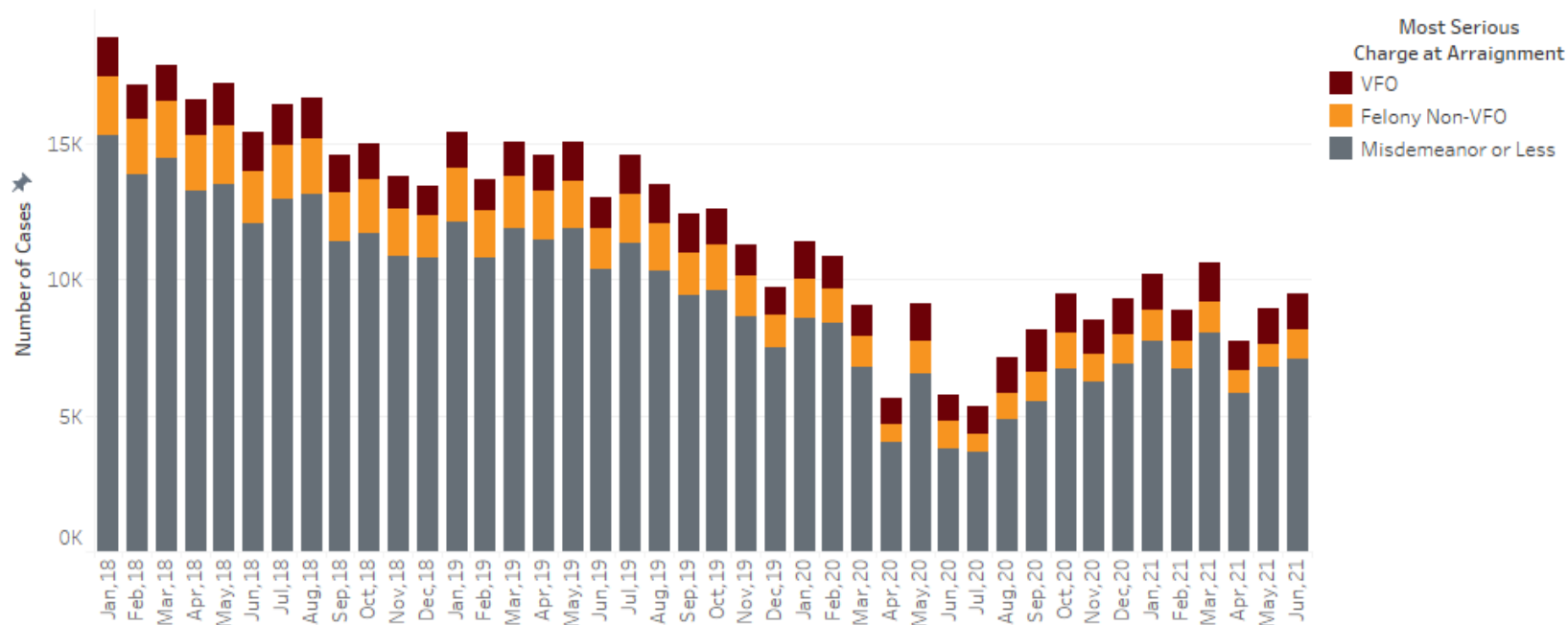

Most Serious Charge at Arraignment

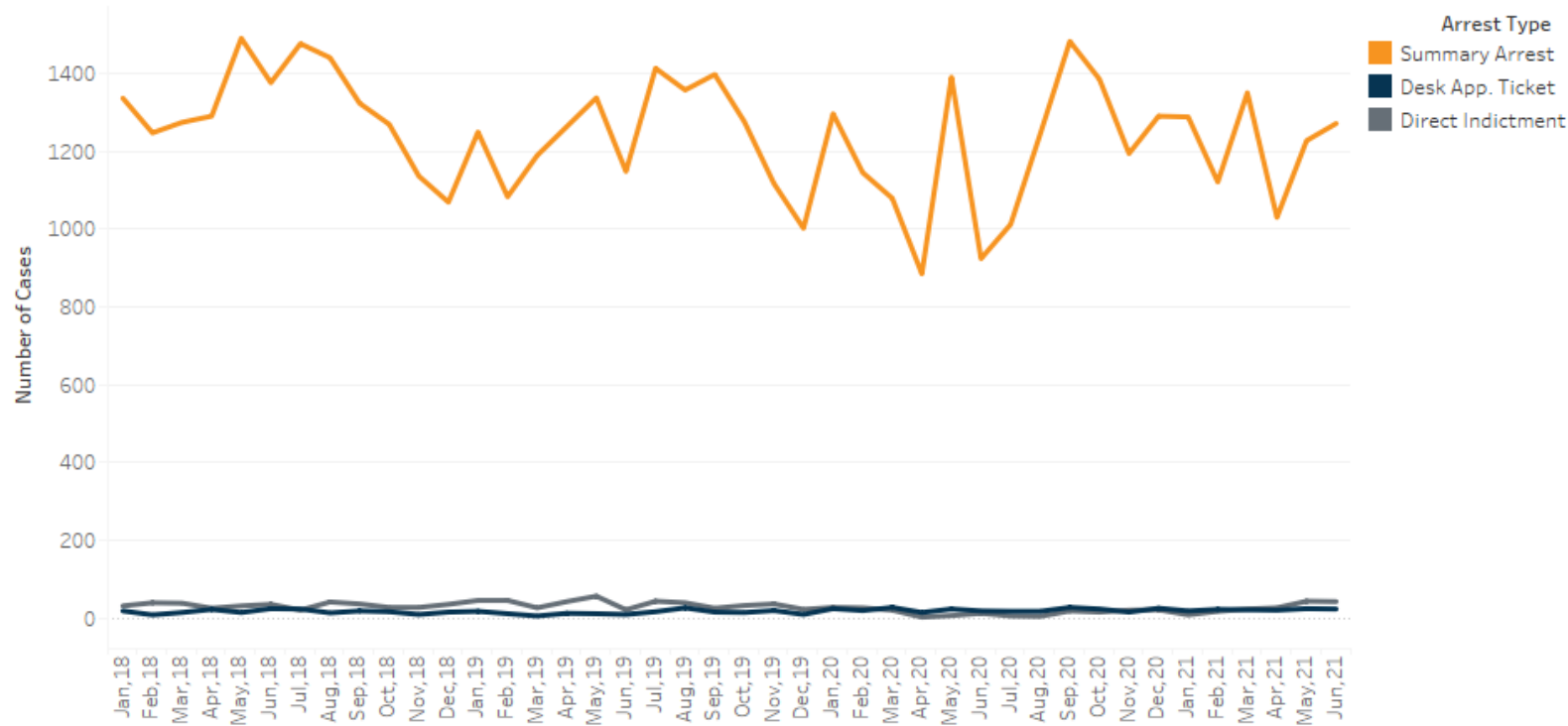

All Citywide Docketed VFO Arrests Each Month



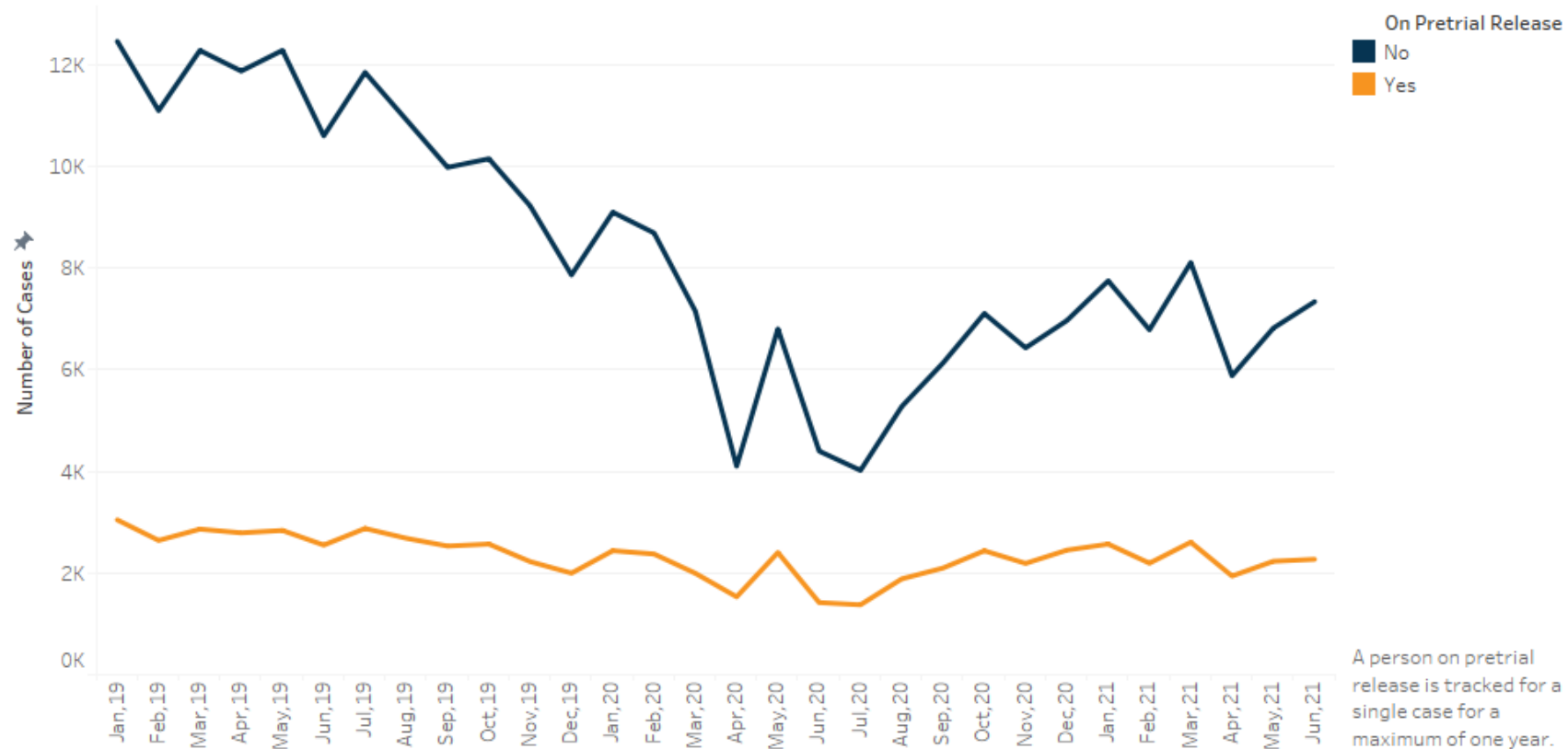

**How much does the
pretrial population
contribute to overall
citywide docketed arrests?**

Most docketed arrests citywide are of people who do NOT already have another pending case (76% in June 2021, down from 81% in 2019 as arrests among the non-pretrial population plummeted in 2020). Pretrial rearrests make up a smaller proportion of total docketed arrests.

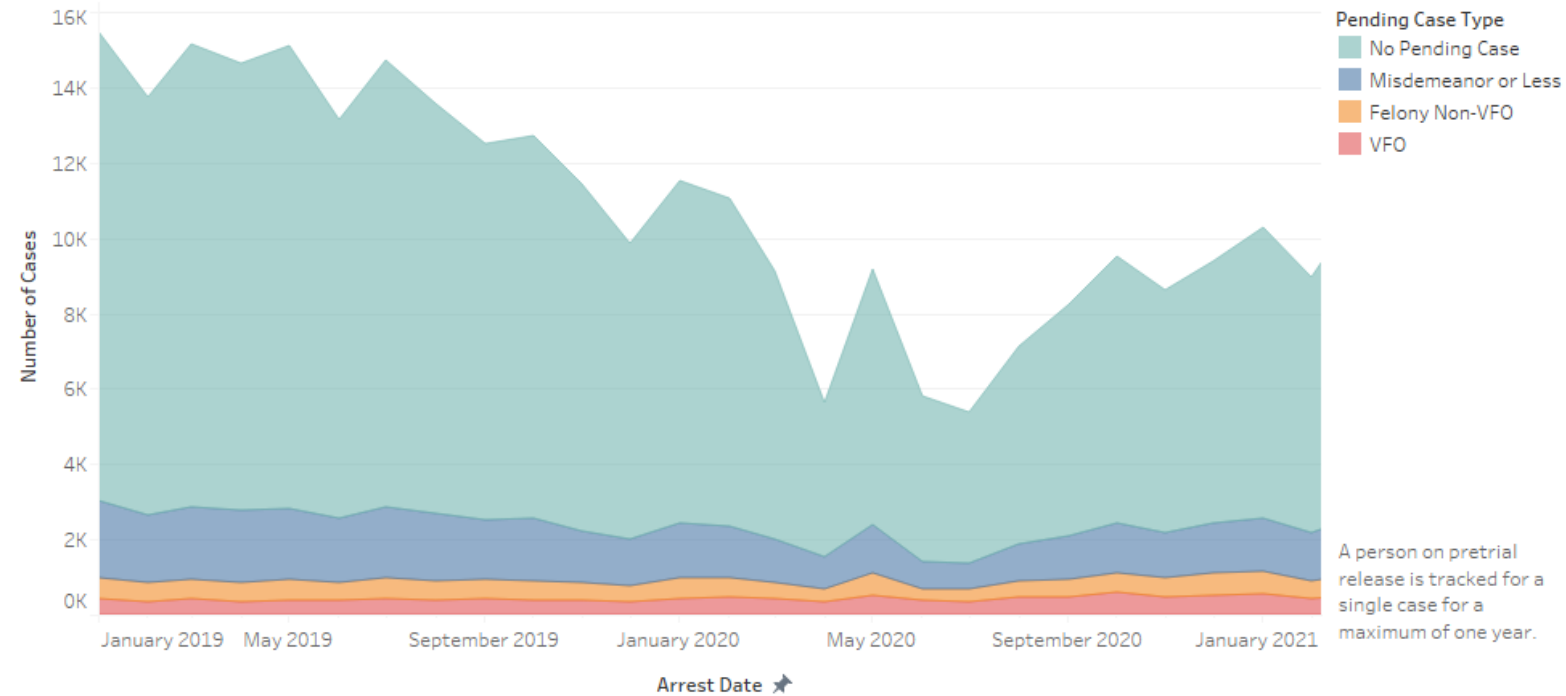

Of all docketed arrests in June 2021, only about 5% already had a pending VFO case at the time of their new arrest. Another 4% had a pending NVF, and 14.5% had a pending misdemeanor (because there were almost 30,000 people in the community pretrial on a misdemeanor in June, though less than 4% of those were rearrested that month).

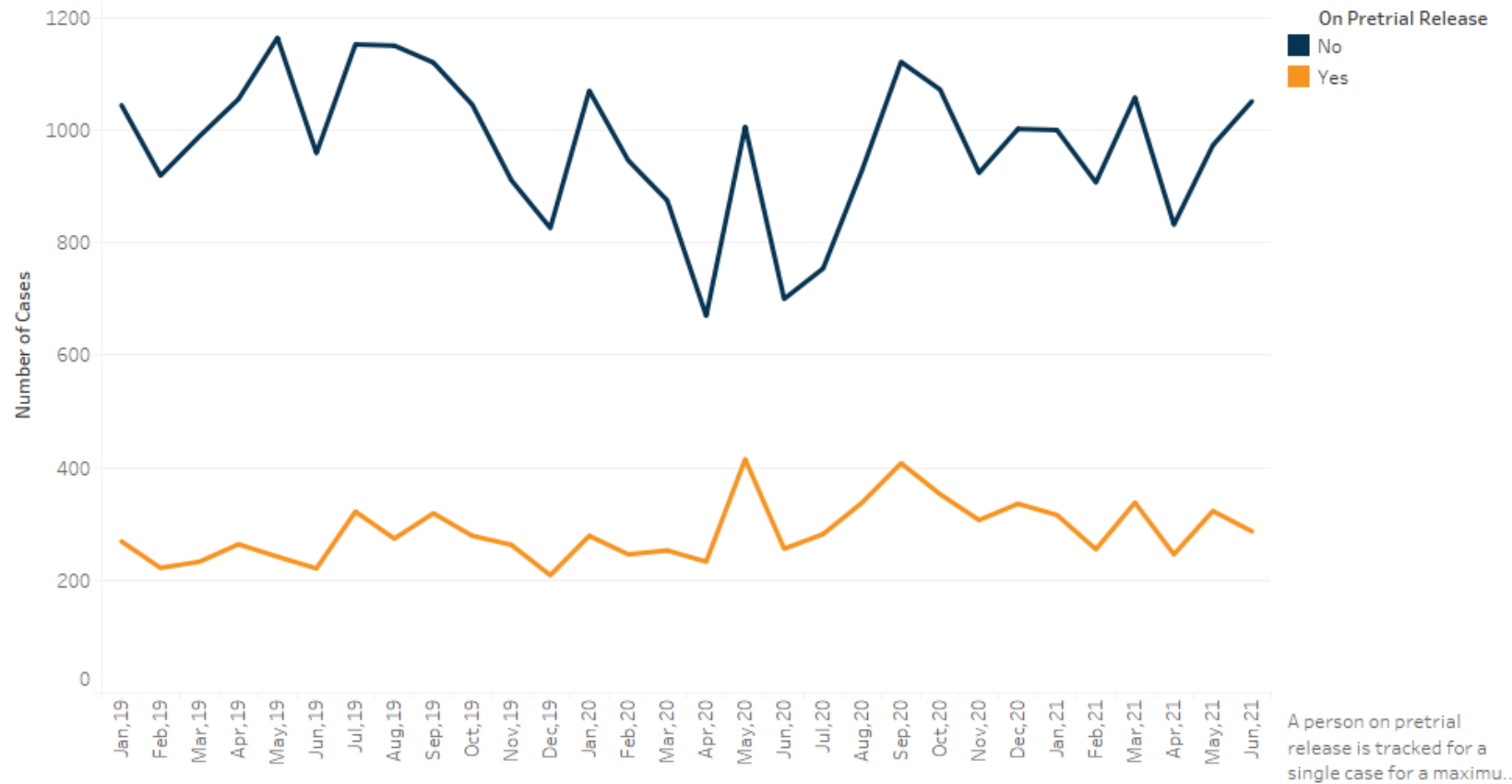

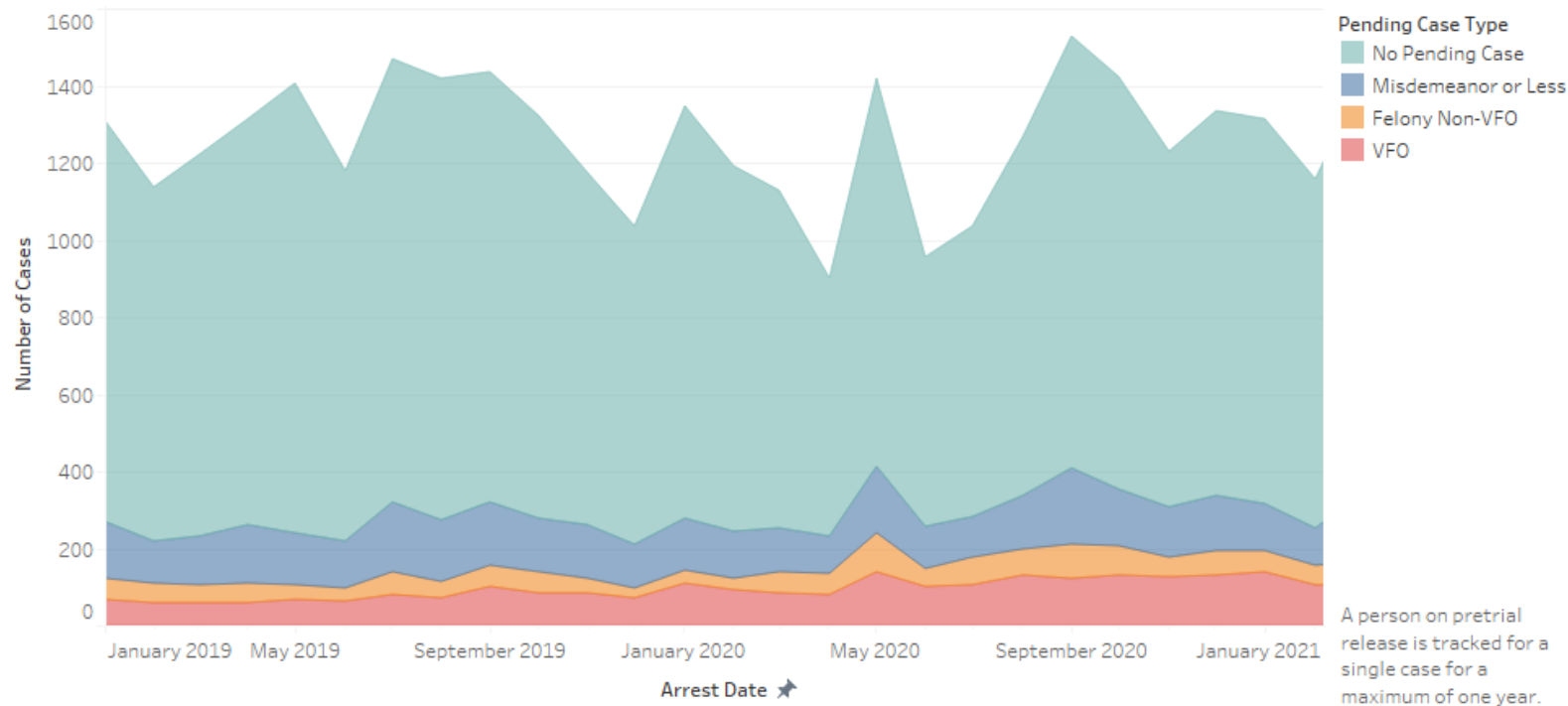

Of all docketed VFO arrests citywide in June 2021, only about 7% had a pending VFO case. Another 4% had a pending NVF, and 10% had a pending misdemeanor. (Pandemic court delays have caused an increase in the number of people in the community on pretrial release for a VFO—but of the almost 10,000 people in June with a pending VFO, only 1% were rearrested for a new VFO that month.)

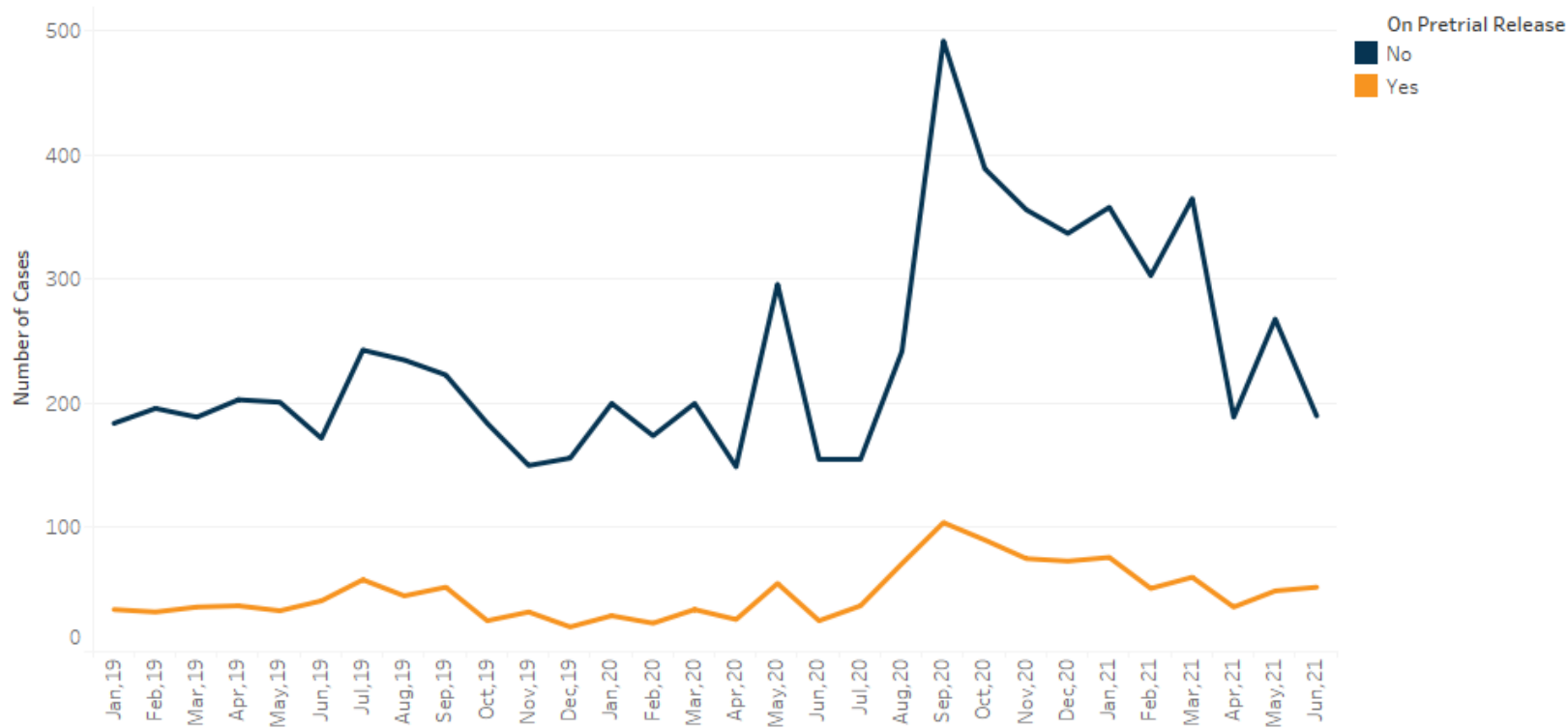

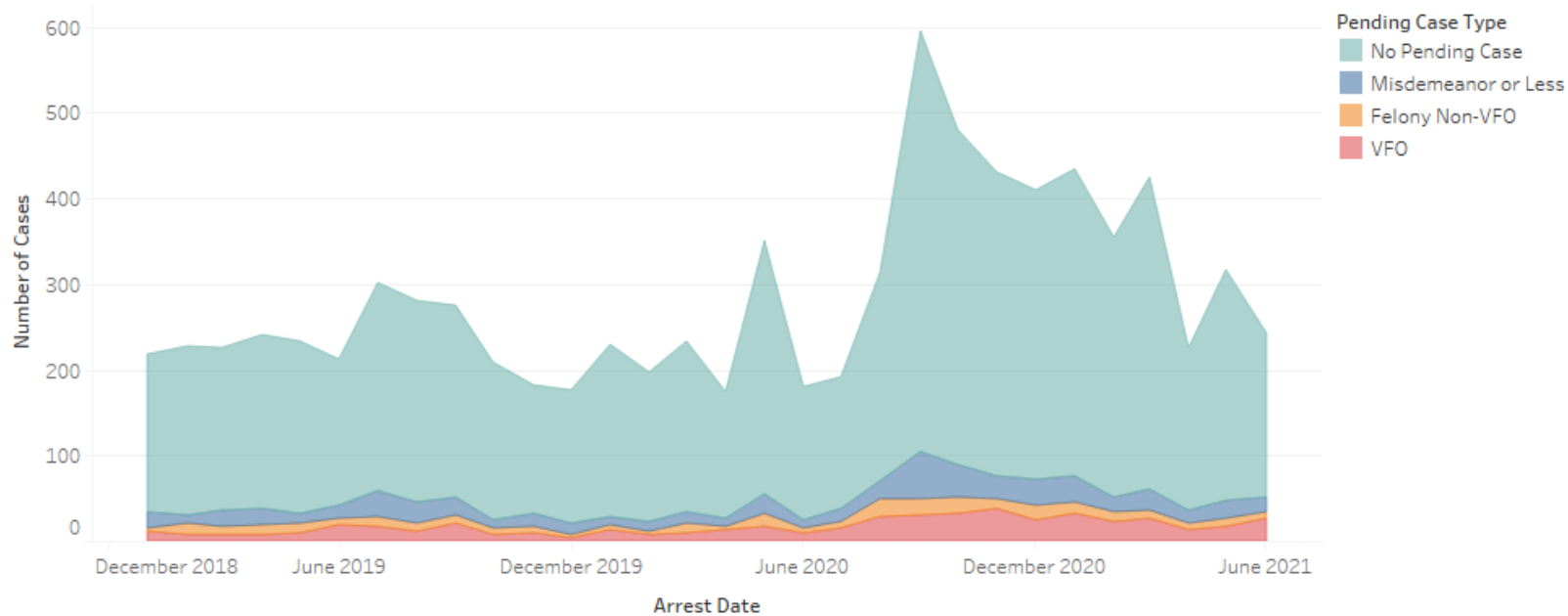

Type of Pending Case



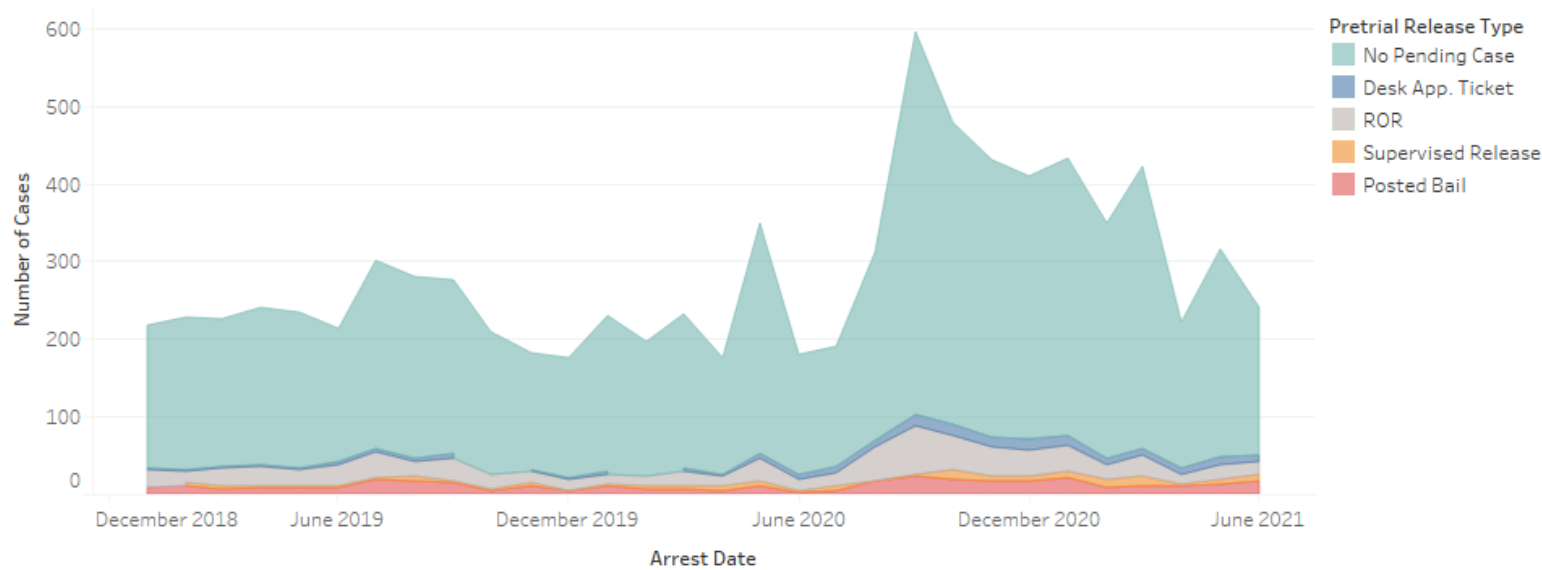

Pretrial Status



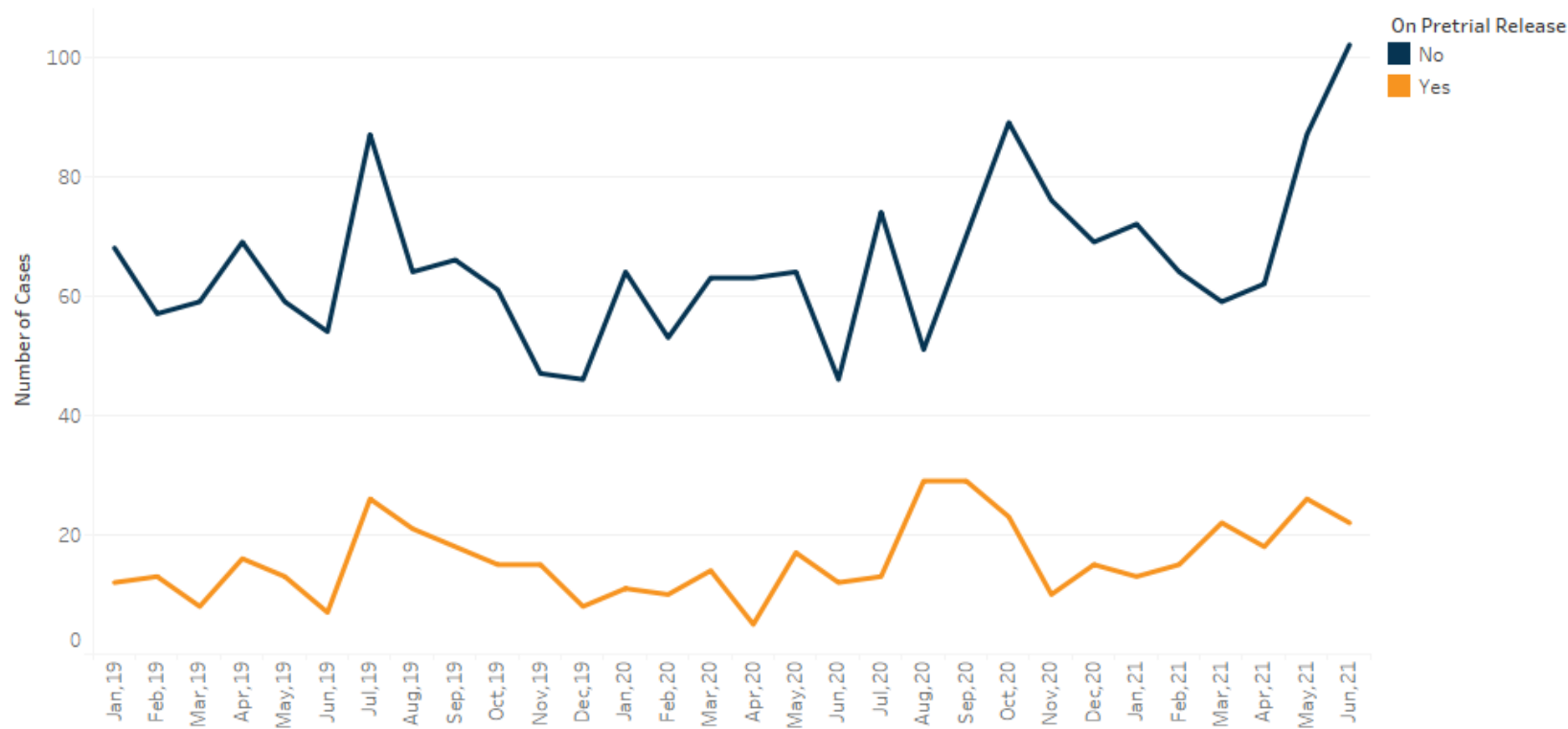

On Pretrial Release for Pending Case



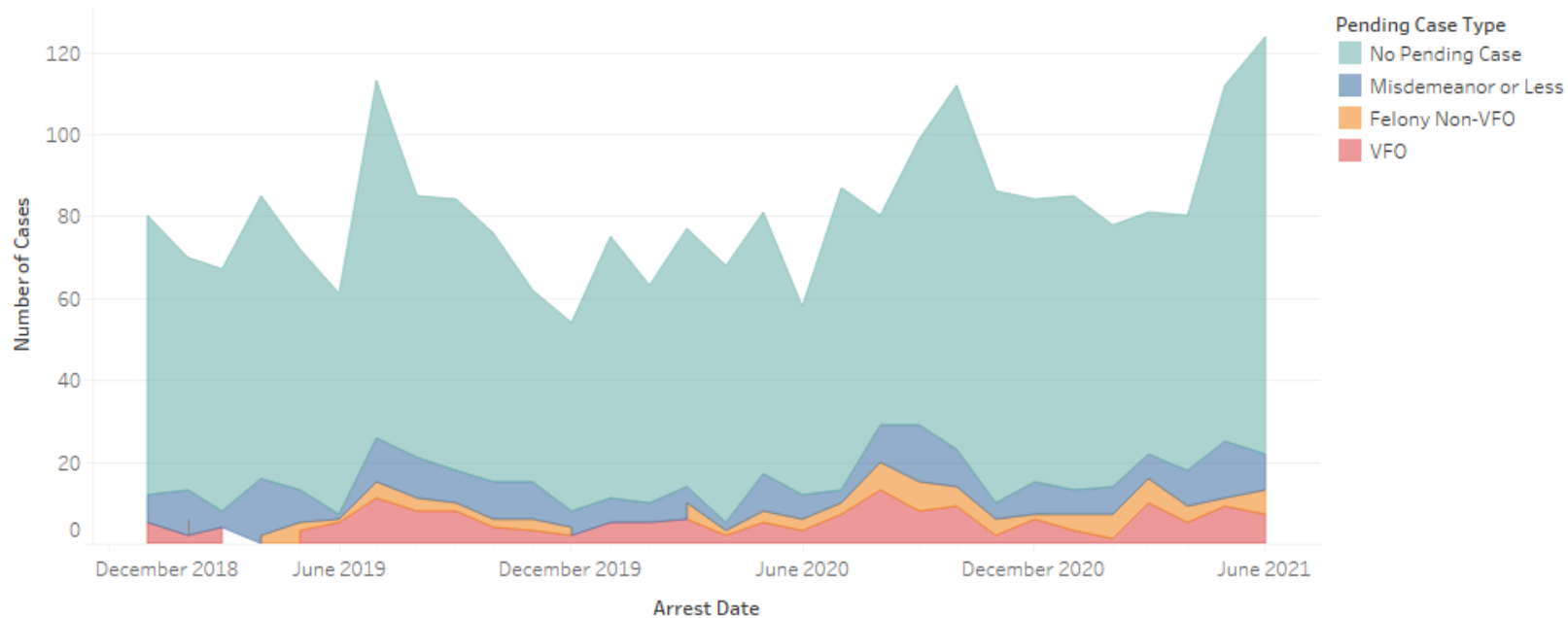

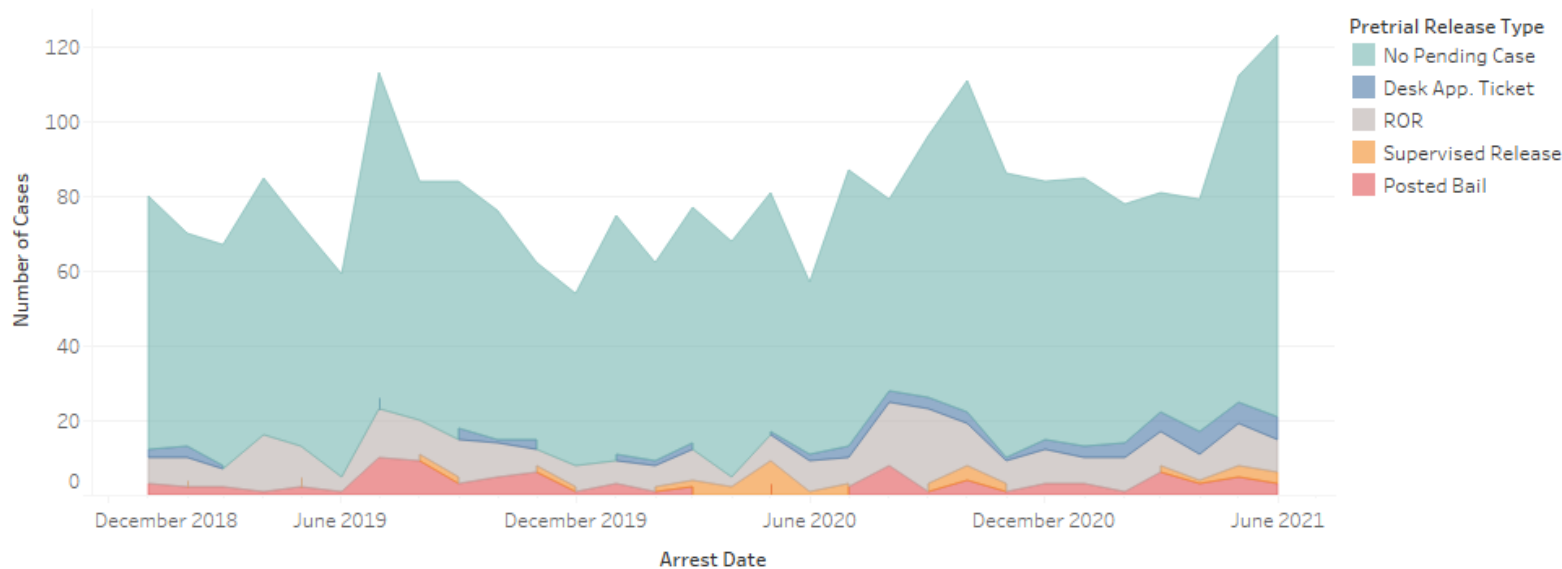

Pretrial Status



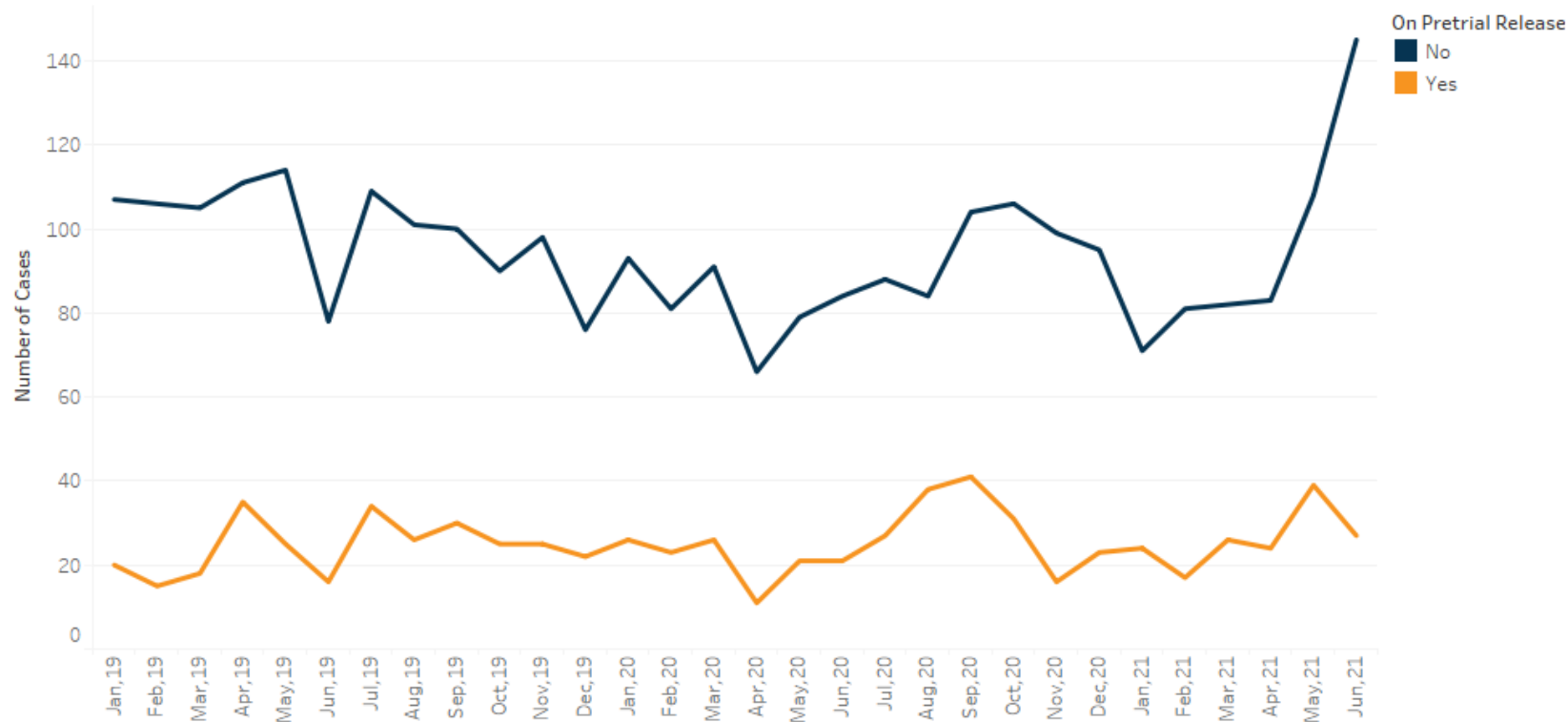

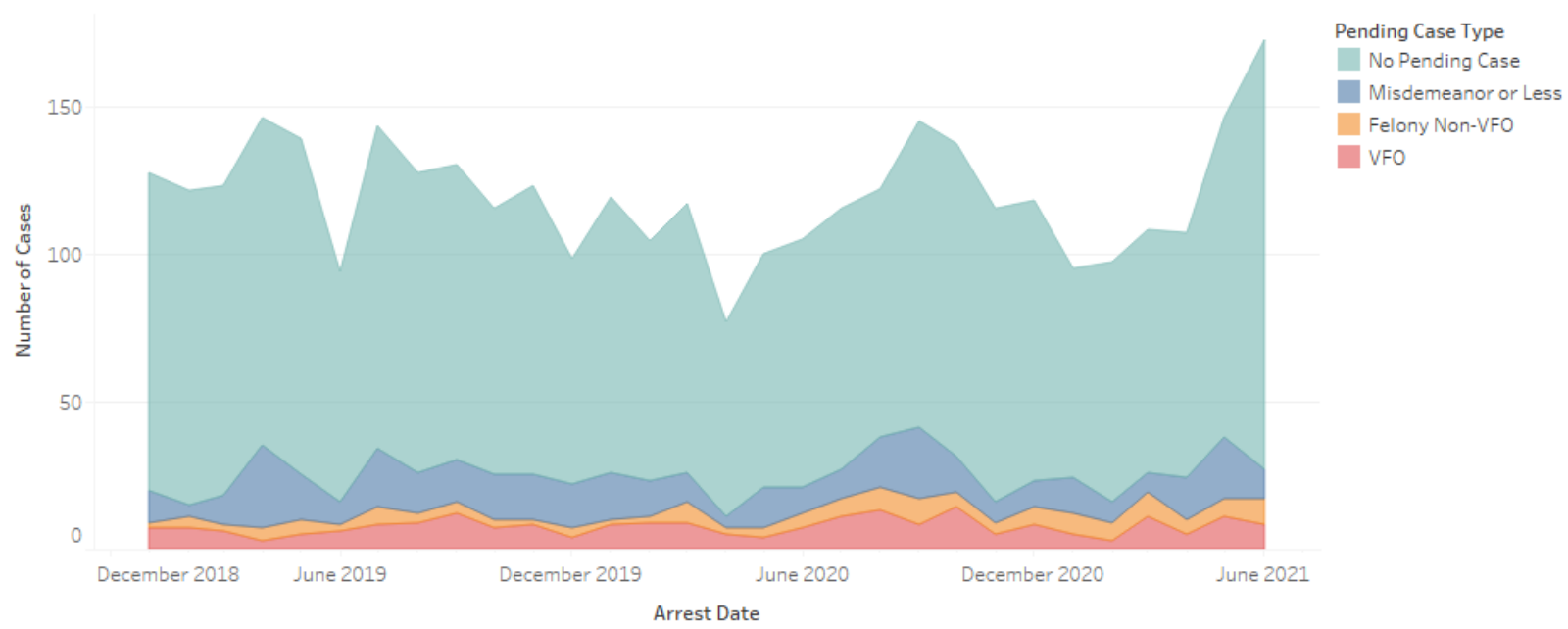

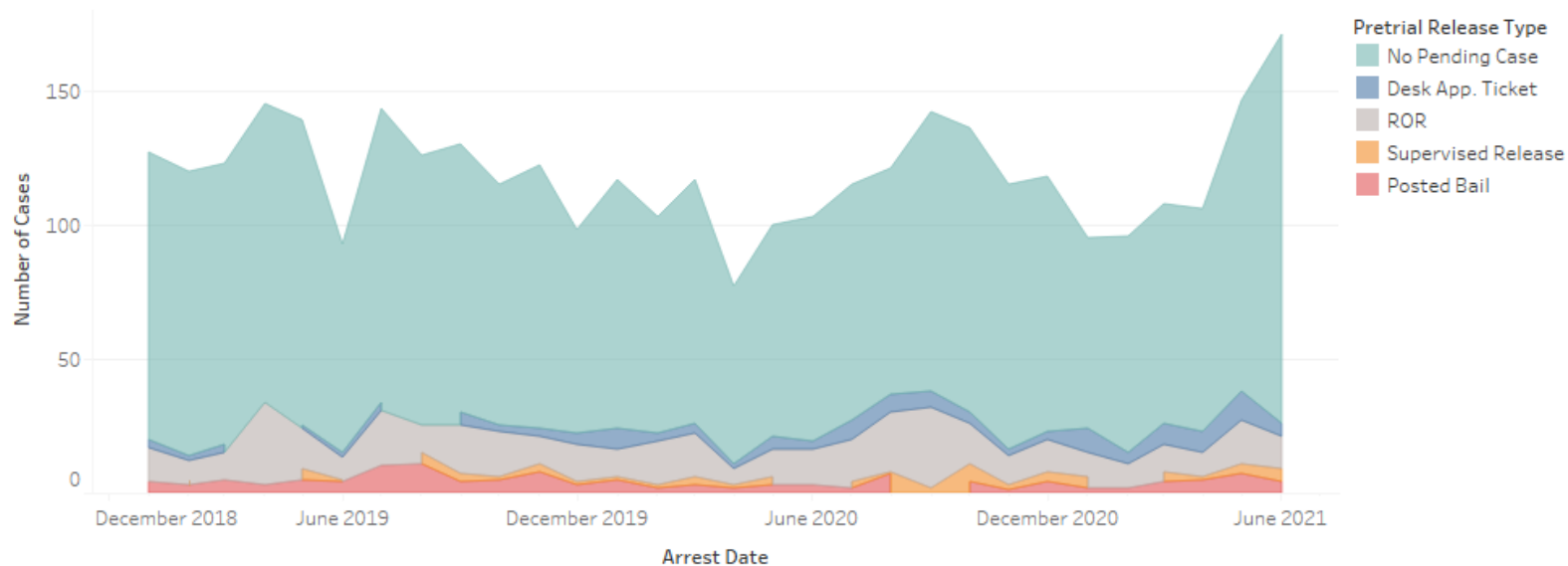

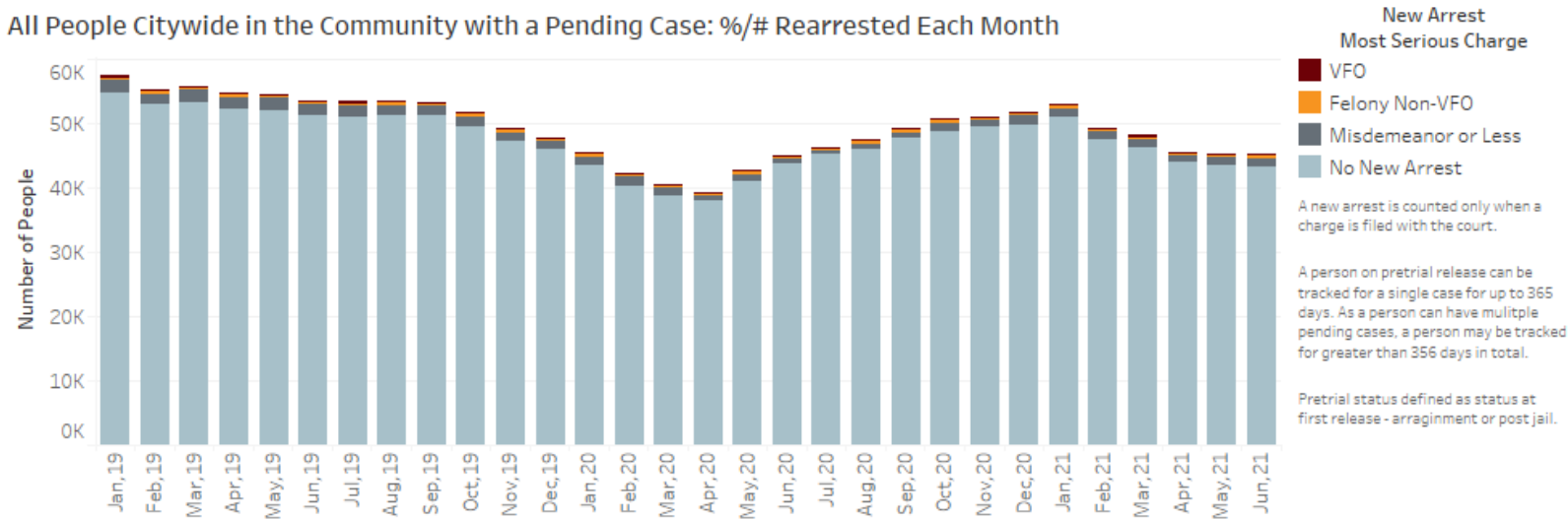

**How does the pretrial
population fare each
month, in terms of rearrest?**

Of the about 45,000 people who were awaiting resolution of their case in the community in June 2021, 96% were not rearrested at all during the month, and over 99% were not rearrested on a VFO.

All People Citywide in the Community with a Pending Case: %/# Rearrested Each Month



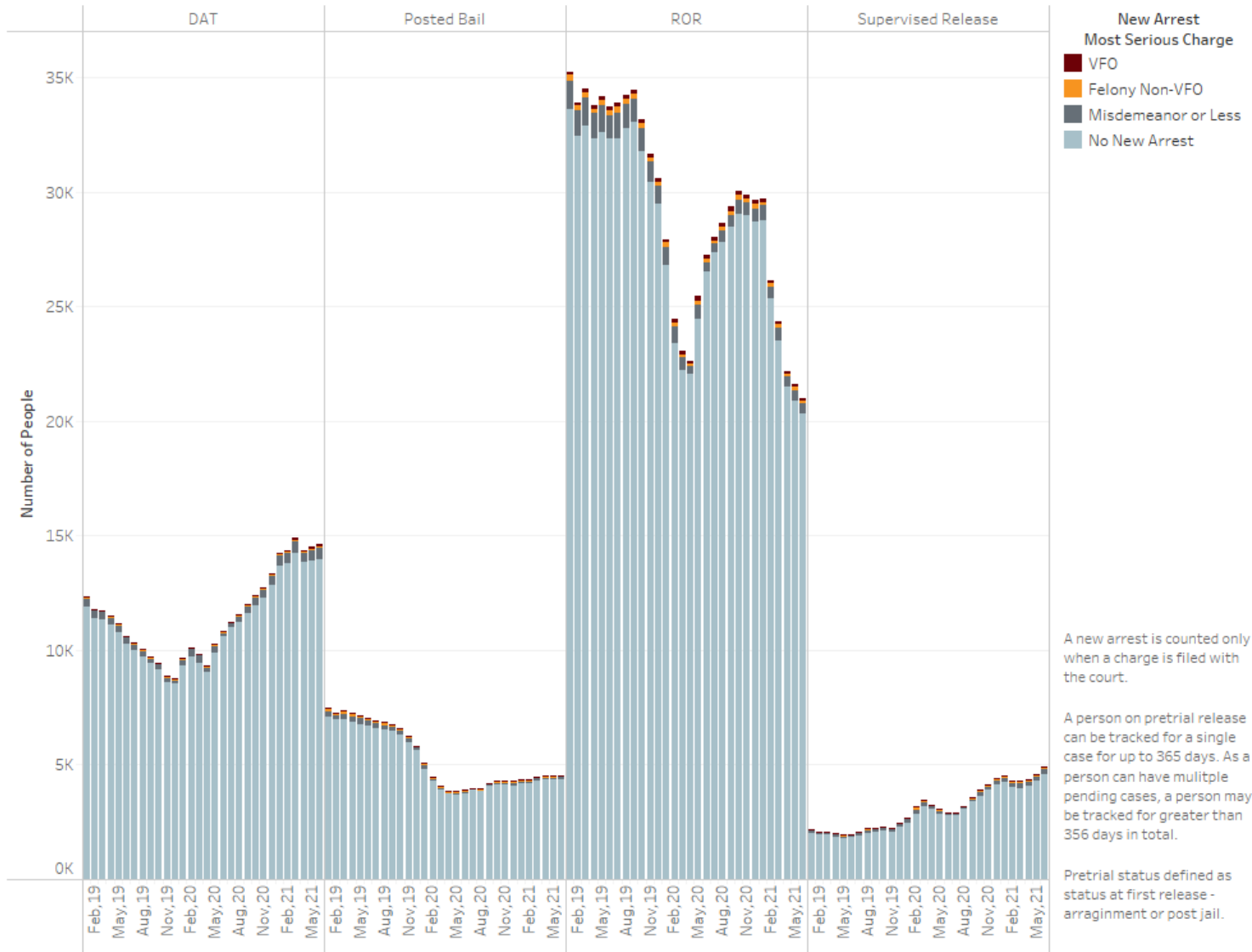

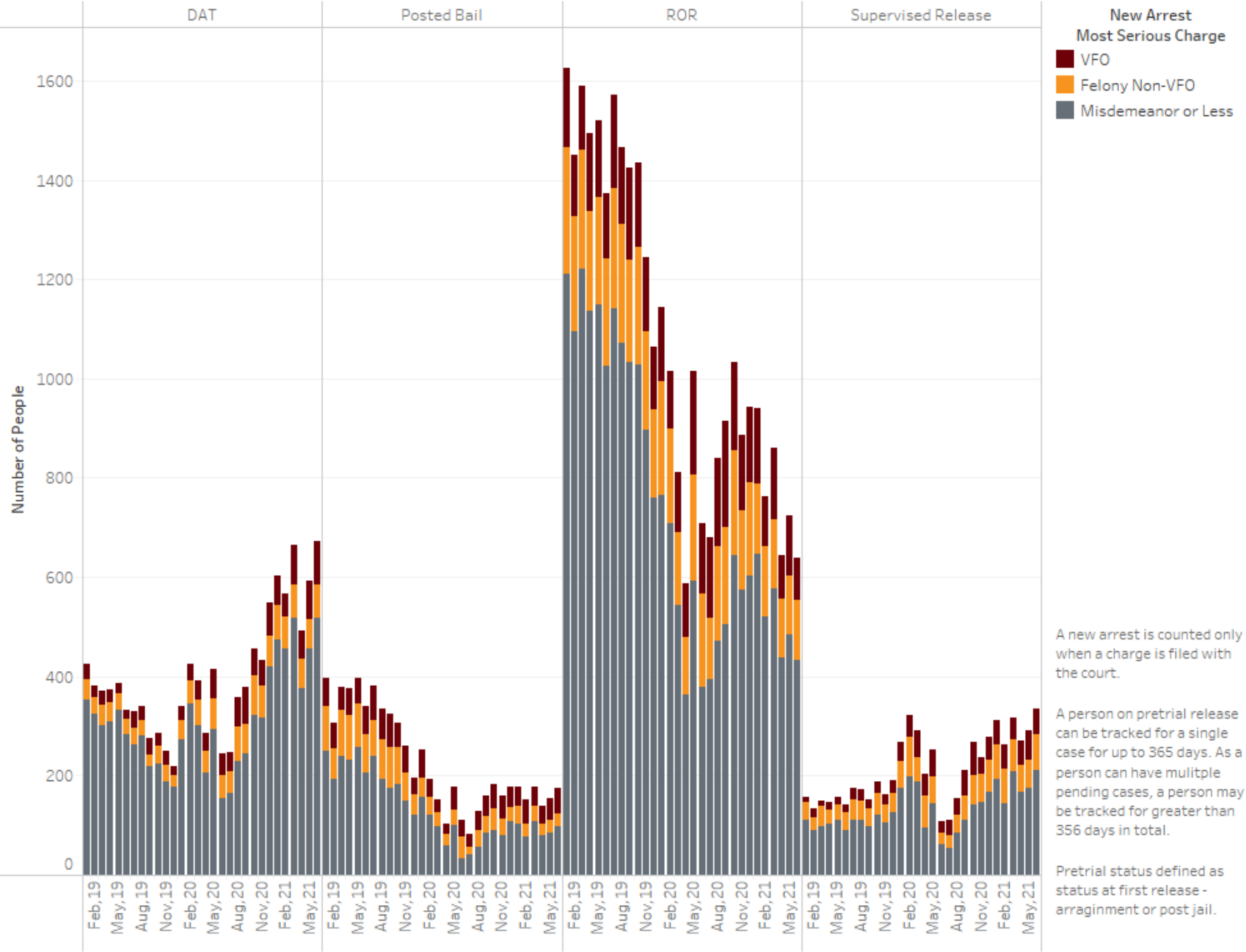
Rearrests of People in the Community Each Month, by Pretrial Status

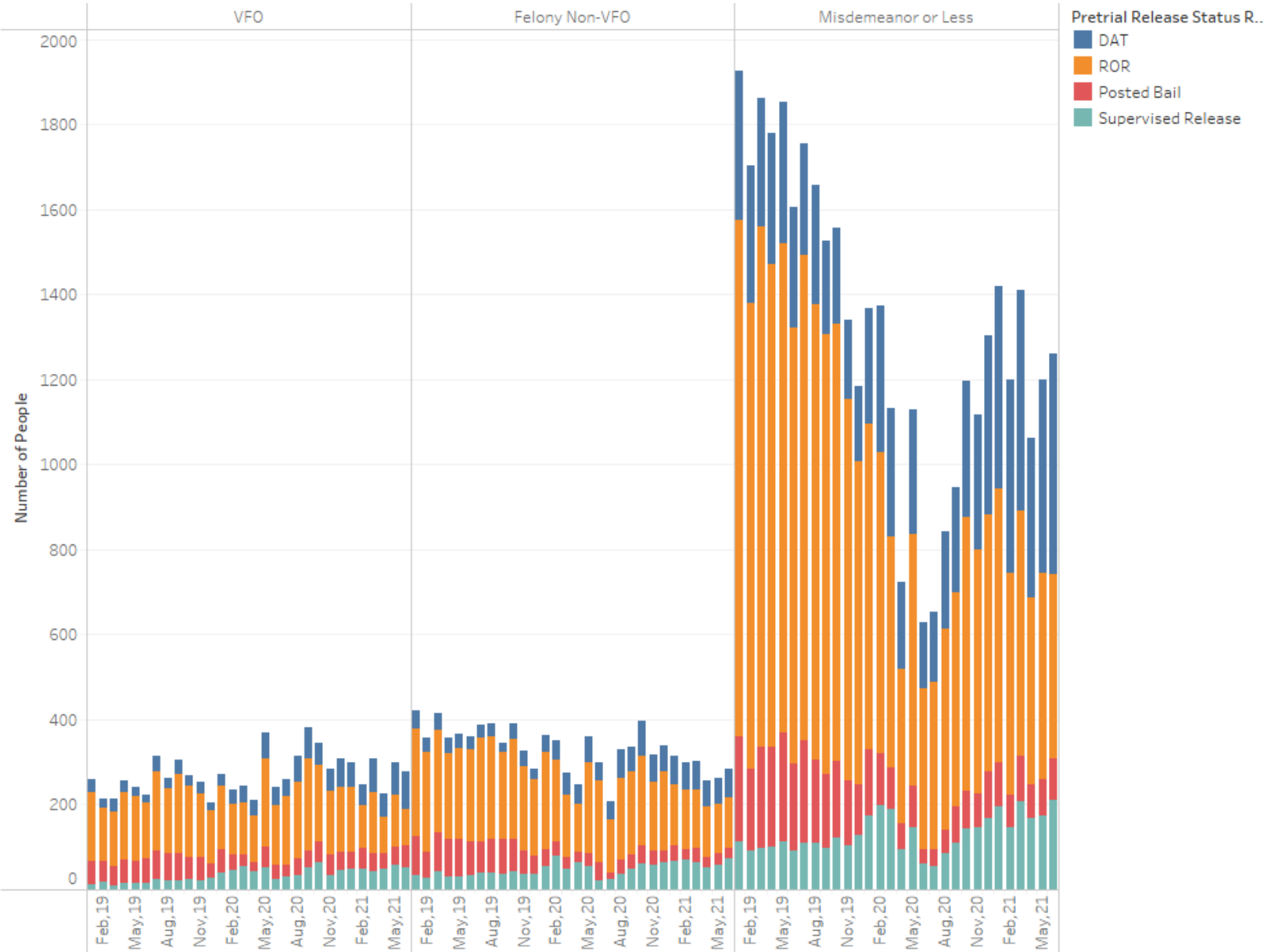
Rearrests of People in the Community Each Month, by Pretrial Status

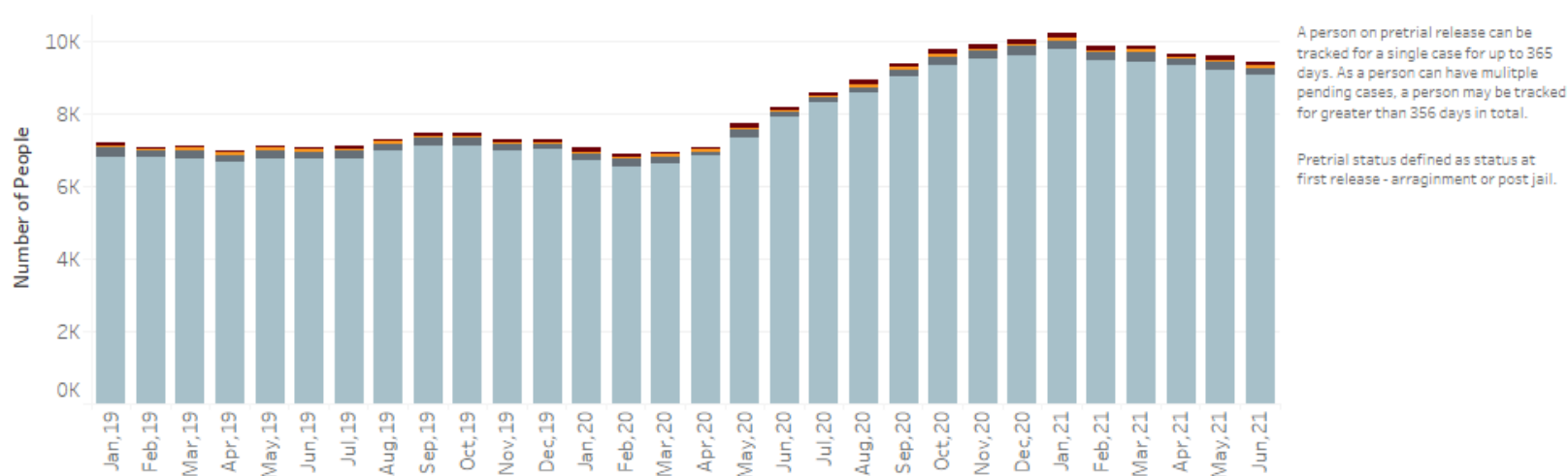

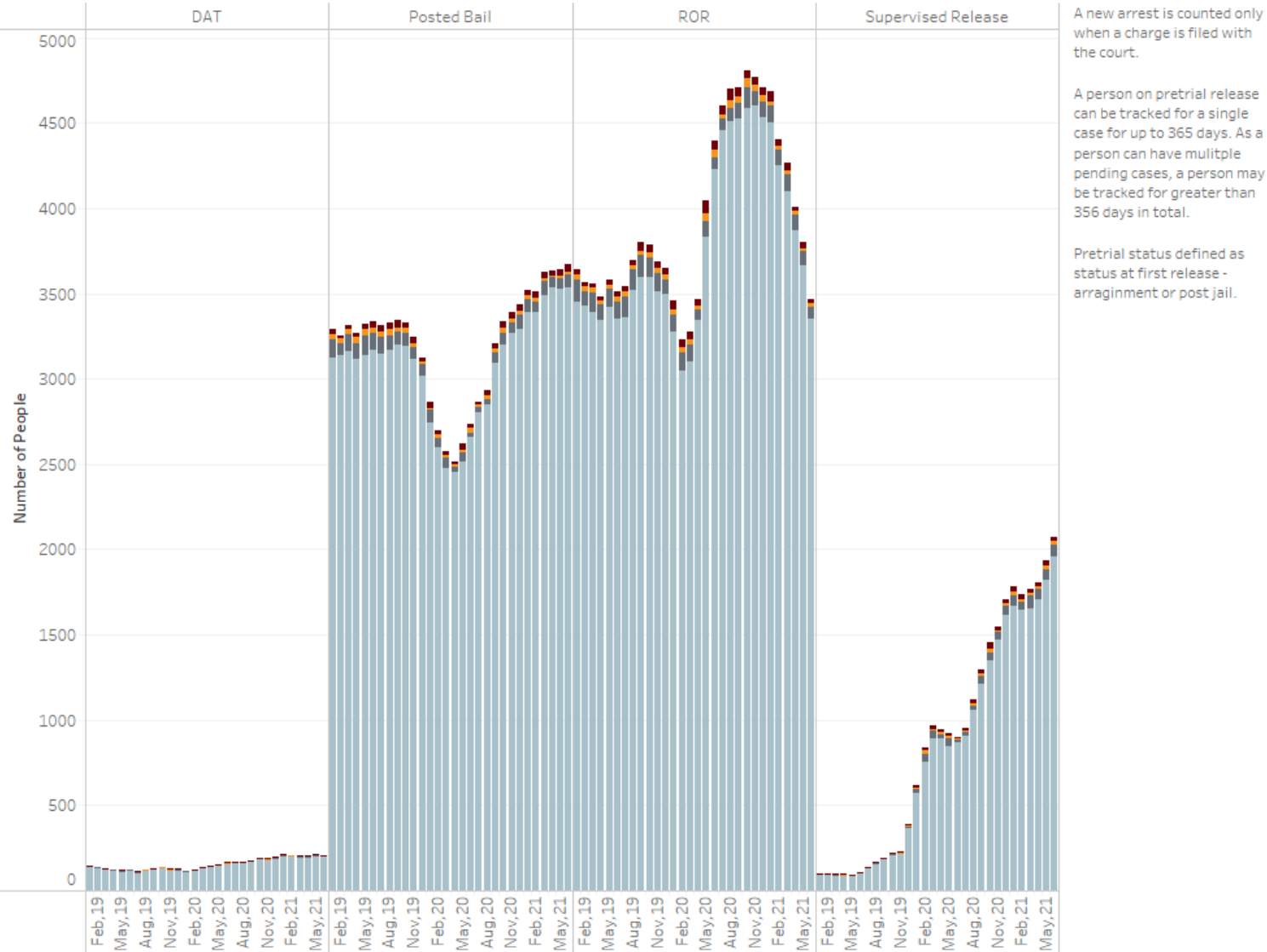

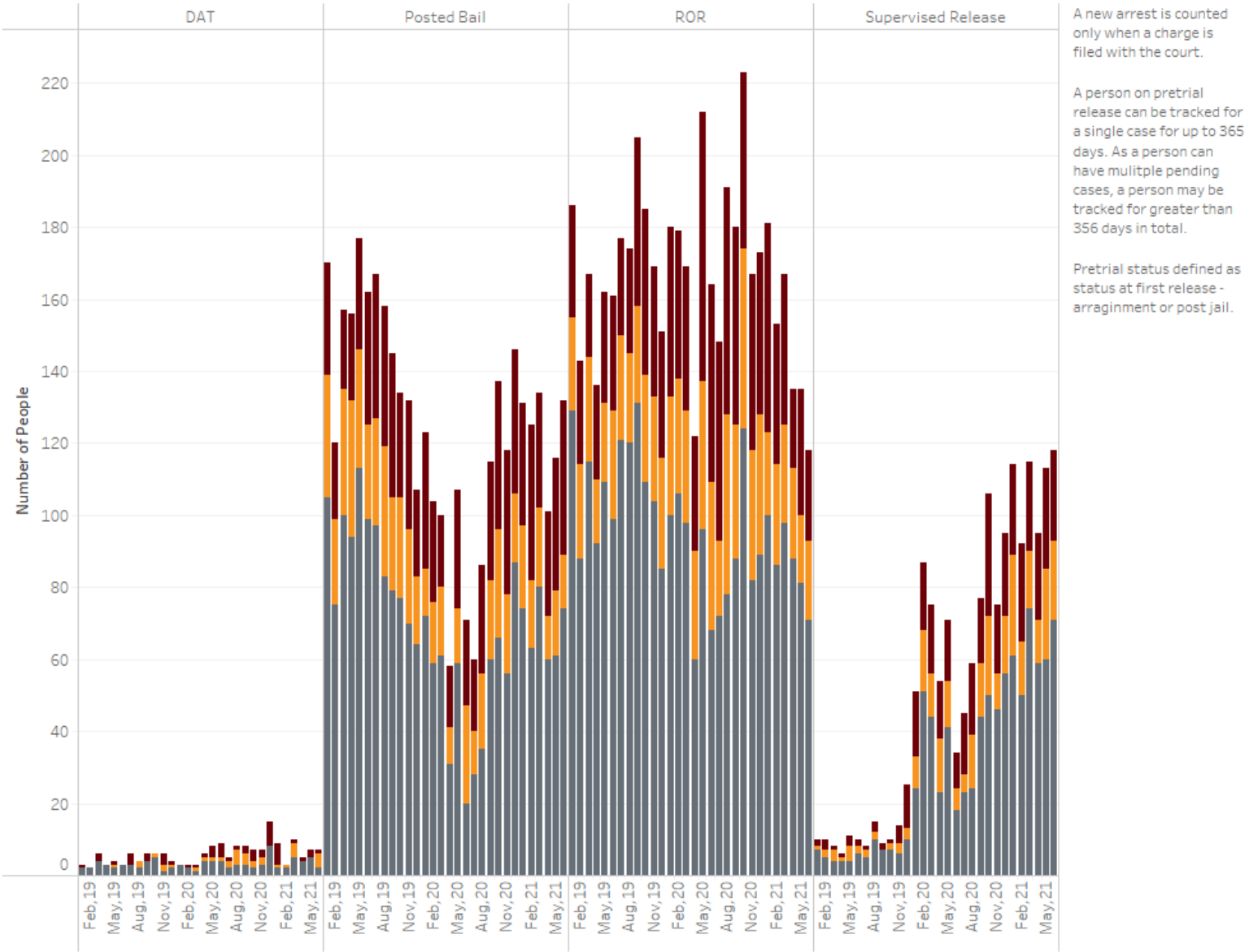
Rearrests of People in the Community Each Month with a Pending VFO, by Pretrial Status



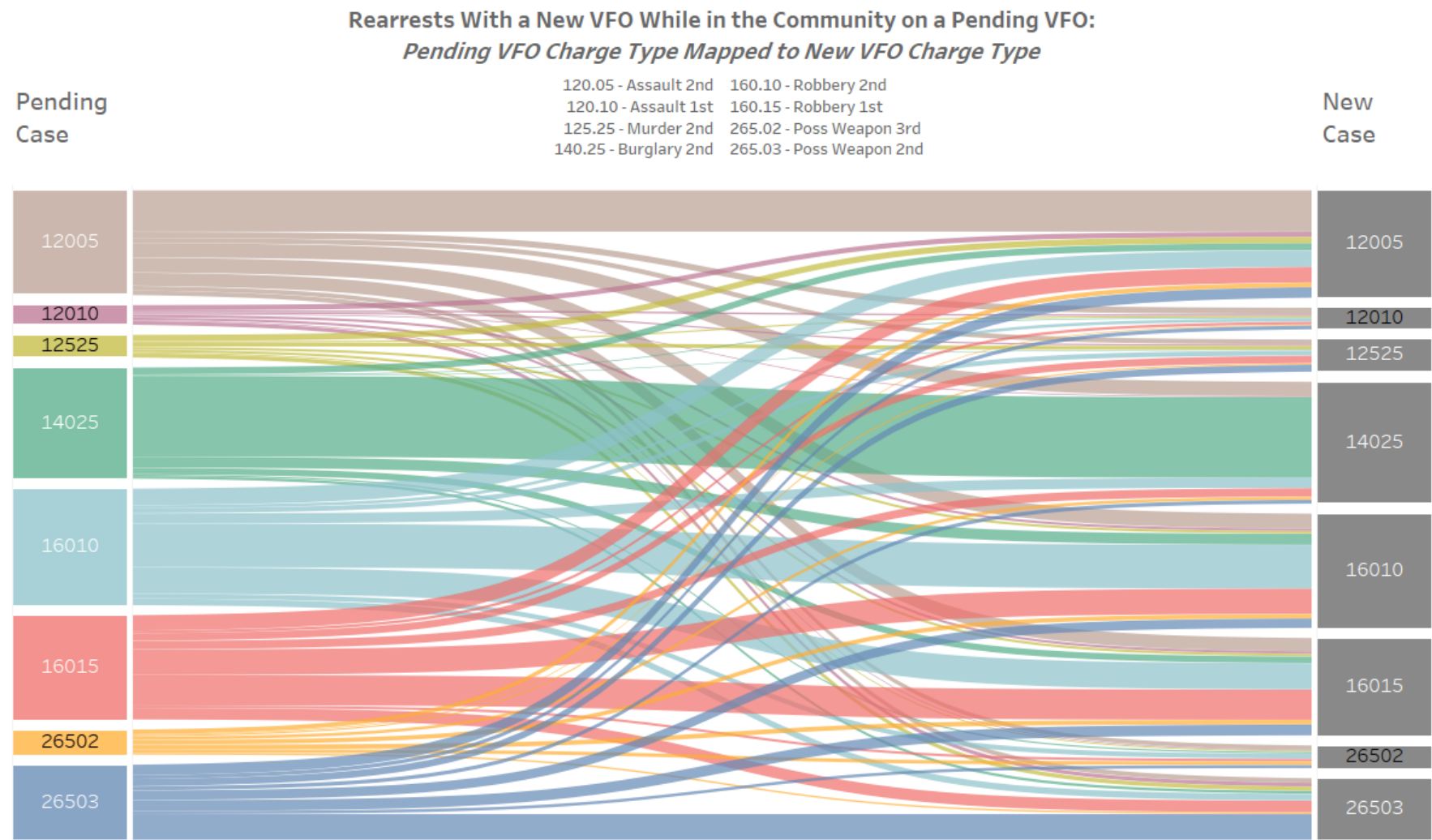
