Introduction

The New York City Mayor's Office of Criminal Justice (MOCJ) submits the following report to the Honorable Mayor of the City of New York and the Speaker of the City Council, Adrienne Adams, pursuant to Local Law 34 of 2023 (LL 34).

This report provides information related to Local Law 34 of 2023, and provides the following information on MOCJ's reentry, alternative to incarceration, and pretrial supervised release, and Atlas programs:

1. Provider program funding amount
2. Number of people served by provider program
3. Information related to re-arrest or compliance by persons to whom services or programming were provided

Program Milestones in FY24:

- In FY24, the City's justice programs served:
 - 30,281 enrolled in Supervised Release (SR)
 - 8,842 enrolled in Alternative to Incarceration (ATI)s
 - 4,009 enrolled in Reentry Services
 - 931 enrolled in the Atlas program
- Data indicates that 95% of individuals awaiting their case disposition in the community in a given month had no new arrests that month, and 98% had no new felony rearrests.
- Within the Supervised Release program, approximately 92% of participants each month had no new arrests, and 97% had no new felony rearrests.
- 84% of ATI participants successfully completed the program.
- Reentry providers successfully placed approximately 1,199 individuals in new jobs and offered additional services including, job training, mental health, mentorship, housing support, and linkage to educational programs.
- The Supervised Release program introduced a promising pilot initiative to enhance service delivery for the group with the highest needs who cycle in and out of the justice system, with early indications of strong reductions in serious rearrest frequency and severity.
- Data collection and analysis were continuously refined to track progress and outcomes more effectively.

Tracking Quality and Performance

MOCJ systematically tracks key performance metrics to evaluate the justice system's efficiency and effectiveness. This includes monitoring case flow, equity, service delivery,

rearrests, and court appearances. Additionally, MOCJ reviews qualitative reports to identify successes and address barriers to effective service delivery.

In FY24, MOCJ built on its robust citywide programmatic foundation by assessing stakeholder needs, and identified gaps within the court programming and public safety landscape. MOCJ's focus was on filling these gaps by introducing essential new services and infrastructure, and ensuring the highest standards of quality. MOCJ enhanced the existing programmatic landscape with upgraded infrastructure and rigorous research methodologies to effectively address gaps particularly among those with elevated needs. MOCJ also launched integrated quality assurance to improve outcomes and identify new strategies across its programmatic portfolio.

Utilizing years of research, MOCJ collaborated across agencies to spotlight a critically underserved population: individuals with disproportionately high involvement in criminal activity, who are also facing significant challenges related to mental health, substance abuse, and homelessness. Despite marked expansions in public safety and justice services across NYC over the past decade, this group has historically lacked access to adequately comprehensive and intensive clinical and supportive care throughout their contacts with the justice system. Consequently, MOCJ prioritized the development of services and infrastructure specifically designed to address the unique needs of this vulnerable population. In FY24, MOCJ implemented an Intensive Case Management (ICM) pilot within the pretrial supervised release programs in Manhattan and Queens to help address individuals with higher needs. ICM has shown promising initial results and should produce improved outcomes for this population in years to come.

Supervised Release

About Supervised Release:

Supervised Release is a court-ordered program and non-monetary condition that provides community-based supervision and support for individuals with pending cases in New York City Criminal or Supreme Court. Supervision is focused on engagement, ensuring that participants return to court and avoid arrest, and connecting individuals with resources and support systems in their communities they can use beyond the duration of a criminal case. Currently, services are provided by four non-profit organizations: Center for Alternative Sentencing and Employment (CASES) in Manhattan, Center for Justice Innovation in Staten Island and Brooklyn, The Fortune Society in the Bronx, and Criminal Justice Agency in Queens. MOCJ invested \$103 million (***actual budget for FY24 \$103,202,225***) for FY24 to fund Supervised Released programs by these service providers.

Data Note

The number of clients served, as defined by the count of people with at least one supervision cycle served, during the fiscal year, is distinct from the number of completed supervision cycles for that fiscal year as some clients have more than one completed supervision cycle within the fiscal year. Demographic (gender and age) variables are expressed as a percentage of the number of supervision cycles completed during the fiscal year, as are court attendance and rearrest rates (see definitions). Tier 1 and 2 designations may be set by the providers based on a risk of missing court and charge, or are mandated by the judge. People placed on Tier 2 have more requirements.

For average monthly rearrest rates, rearrest is at the case level. These cases are in the community because they were ordered to supervised release at arraignment but may not remain in community for the entire pretrial period. Rearrest rates are calculated by borough of the case's arraignment, which usually but not always corresponds to provider. Average monthly rearrests reports the average percentage of the borough's full supervised release caseload in any given month, regardless of when participants were ordered onto supervised release.

Definitions

Number of clients served: Count of people with at least one supervision cycle (stay) served during the fiscal year.

Court attendance rate: Distinct scheduled court dates for completed supervision cycles that did not have a warrant issued, as a percentage of all completed supervision cycles for that fiscal year.

Rearrest rate: Supervised release stays with rearrests filed in court (arraigned) during their stay with supervised release, as a percentage of all completed supervision cycles for that fiscal year.

Supervised Release Case Studies:

Participant 1

Bronx SRP

Fortune Society:

Participant 1 was a 22-year-old male who was placed in the Supervised Release Programming the Bronx on a tier 1, level 3 status. As the provider staff got to know participant 1, he shared that he wasn't making the best decisions due to the environment in which he lives in, which led to his arrest. While on SRP he had to follow check-in guidelines, which included two phone check-ins per week. Participant 1 always opted to come in person for his check-ins and made sure he inquired about all services happening in the Bronx space as he was curious of what the program had to offer.

Since joining SRP Participant 1 has participated in the three-week Job Readiness course offered by The Fortune Society, which helped him reframe his mindset and focus on the positive things programming can offer. He also began to explore other programs and pathways as he gained knowledge of all the services Fortune offers.

As time passed, he began to inquire about the Bloomberg-Fortune Fellowship program, which is a 16-week paid Fellowship with the Bloomberg Corporation and after two months he successfully went through the vetting process and was selected to be a fellow. This fellowship serves justice-involved individuals wanting to join the workforce to achieve sustainable, full-time employment. The fellows are assigned to one of Bloomberg's seven units to learn skills that will help them gain employment. Participant 1 excelled in the fellowship and has been consistently attending and shared his progress with the Judge who has expressed how great of a job he is doing.

Participant 1 was also selected to speak in front of guest representatives from the Department of Justice at an event that took place at The Fortune Society's main hub in Long Island City. He also volunteered to be part of the Research Advisory board led by Fortune's Senior Director of Research with the Center for Research, Inquiry and Social Justice.

Participant 2

Queens SRP (QSRP)

CJA:

Participant 2 was released to QSRP. He met with his assigned Clinical Case Manager on a weekly basis and actively engaged with the program provider remaining in compliance throughout his tenure. His initial assessment indicated a need for a number of services, as was a disabled Army veteran with service dog, homeless due to the nature of his ongoing case. Participant 2 chose to remain on the streets and frequently stayed on a construction site in the Long Island City area due to its proximity to the Queens provider office. His unfamiliarity with the NYC area and its transit system proved to be challenging. Participant 2 instinctively relied on his military training and

survival skills, as well as the keen senses of his service dog to navigate throughout the boroughs.

Participant 2 was connected to CJA's Peer Services program and felt a strong connection to our Senior Manager of Peer Services due to both identifying as disabled military veterans. During this time, the Clinical Case Manager and Senior Manager of Peer Services closely collaborated to support the participant in connecting to various resources to address his housing, veteran's advocacy, and treatment needs. As the winter continued and inclement weather set in, Participant 2 mental and physical health decompensated and led to him disassociating and ending up in New Jersey, becoming separated from his service dog in the process. Once he realized where he was, Participant 2 was able to remain in communication with his Clinical Case Manager, who supported him in navigating back to New York City.

Shortly after our Senior Manager of Peer Services accompanied Participant 2 to the VA hospital for the second time, his case was dismissed, and Mark was exited from our program. However, it is important to note that due to his engagement with Supervised Release, concrete services were in place to address his critical needs from a person-centered and recovery-oriented perspective. The team's engagement helped him identify and address his own barriers towards engagement and supported him with links to additional services beyond our program that created a continuum of care to further meet his needs.

Alternatives to Incarceration (ATIs)

About ATI Programs:

ATI programs are diversion programs, mandated by judges in court, that provide participants with holistic, supportive services in their communities instead of a jail or prison sentence. ATI programs can increase stability and well-being, reduce the court's reliance on incarceration, increase public safety, and enhance accountability while allowing people to remain in their communities. Services include: mental health and substance use treatment, counseling, job readiness, education assistance, benefits enrollment, and case management. MOCJ currently invests approximately \$32 million annually to fund 23 ATI programs administered by 14 services providers throughout NYC.

Data Note

This report reflects data on individuals who were enrolled in a MOCJ-funded ATI program between July 2020 to June 2024 and were discharged during FY24 (July 2023 to June 2024). The denominator used for the rearrest rate is the total number of people who could be successfully matched to court outcome data, which is overall 92% of participants across all ATI providers. The average monthly rearrest rate is the number of clients rearrested for a felony in each month divided by the total number of clients enrolled in the ATI program for that month. This was then averaged across all 12 months in Fiscal Year 2024.

Definitions

Completion: individuals who successfully met all requirements set forth by the ATI program are considered complete

Felony Rearrest: People with rearrests filed in court (arraigned) any time after their start date while enrolled in the program

CASES: newSTART

Population Served: 16+ year olds charged with a Misdemeanor (primarily at arraignment)

Length of Mandated Services: 1, 3, or 5 sessions (up to 6 months or 180 days for completion)

Example of Services Provided: Rapid, expert risk and need screening, intensive individualized supports, motivational interviewing and CBT skills used to provide trauma-informed care, specialized interventions for repeat participants, basic needs resources

CASES: ROAR

On April 14, 2024, John was arrested for possession of a loaded firearm. John began participating in the CASES ROAR program pre-plea since his enrollment on June 6, 2024 in hopes of earning a non-incarceratory ATI disposition. John has since been participating in the ROAR Enhanced Gun Track, which includes gun violence prevention groups, individual therapy, and one-on-one sessions with the ROAR Engagement Specialist.

From day one, John presented as future-focused and eager to take advantage of resources made available at ROAR. John demonstrated his commitment by fully engaging in programming and maintaining excellent attendance, all while being employed as a home health aide. In August of 2024, John obtained his HSE diploma and set ambitious goals to eventually attend New York University to study Econometrics & Quantitative Economics.

In October 2024, John was referred to the Beyond Boxing program, a program for justice-involved youth that includes 3 months of a social-emotional learning curriculum and a 3-month parallel boxing protocol. John's instructors and mentors at Beyond Boxing acknowledged his dedication in both the social emotional classroom and in the gym.

For the past seven months, John has been an exemplary participant. He was accepted into Bronx Community College in December of 2024 to begin his Associate's Degree in Mathematics, and still has plans on attending NYU in the future. He is scheduled to return to court in March of 2025, and his peers and mentors at ROAR commend him for his success and dedication.

Common Justice:

Mr. B was a part of a serious assault at the age of 19. He was given the opportunity to participate in Common Justice following the assault. Mr. B grew up in Jamaica and immigrated to the U.S. at the age of 9. Mr. B was exposed to severe community violence, grief, and trauma in the early years of his life. Throughout his time at Common Justice, Mr. B also experienced homelessness, became a father to twins, lost a close friend to murder, and encountered several barriers to obtaining employment. The compounded trauma and grief often contributed to low motivation and inconsistent program engagement during his earlier phases of the program. However, despite the daily challenges, Mr. B persisted and used fatherhood as his motivation to continue showing up.

During his restorative justice circles at Common Justice, Mr. B was present, apologetic and accepted responsibility for the harm he caused. He was remorseful and felt a need to not only repair the harm, but to also set an example for his children that

growth and change is possible. Mr. B began attending therapy and volunteering at a food pantry. Mr. B also showed commitment through his participation in the men's group MOVE (Men Opposing Violence) where he attended consistently, welcomed advice on fatherhood, and fostered meaningful connections with his peers. Mr. B continued to demonstrate dedication to the restorative justice process and eventually landed a paid fellowship with Drive Change where he will gain full-time training and support for long-term employment. Mr. B eventually joined the Graduate Leadership Circle of Common Justice.

CASES: NCS

On August 5, 2024 Mr. J, a 47-year-old cisgender male, was assessed by the CASES Alternative to Incarceration Intake Assessment Team to determine eligibility. Mr. J ultimately pled guilty to menacing in the second degree. As a part of his plea agreement, Mr. J was mandated to participate in CASES NCS for three months in lieu of incarceration. As a part of his intake assessment, Mr. J shared that he had been diagnosed with Bipolar I, Schizophrenia, Paranoid Personality Disorder, and Depressive Disorder as early as 18 years old. He also dealt with many complex traumas surrounding his upbringing, including physical, emotional and sexual abuse, that affected his ability to navigate adulthood.

Upon enrolling in the NCS program, Mr. J expressed clear goals that included being connected to mental health services, recertifying his benefits, engaging in more prosocial activities, and obtaining employment. Prior to his legal troubles, Mr. J was a high school teacher for 25 years but stopped working in February 2024. NCS assisted Mr. J with updating his resume and applying for jobs in the education field. NCS also worked with Mr. J to find adequate mental health treatment, and he was eventually connected with a provider who was able to appropriate support.

Mr. J remained compliant with his mandate all while navigating these various avenues of adulthood. With the guidance and support from NCS staff, Mr. J was able to confront and overcome the many challenges he faced. By the end of his mandate, Mr. J completed his legal requirements and gained full-time employment. He was sentenced to time served due to his successful completion and the case was dismissed. NCS's combination of practical support, psychoeducation, and vocational guidance enabled him to chart a path forward, one that was centered on stability in all aspects of his life.

Community Justice Reentry Network (CJRN)

About Reentry Programs:

Reentry services were established to address the needs of individuals reentering the community following involvement in the criminal justice system. Reentry programming began in 2018 with Jail to Jobs, focusing on providing paid transitional employment, job training, access to higher education, and supportive services for participants. While employment remains a key component of Reentry programs, the initiative expanded in January 2022 to offer more holistic services. This expansion includes individualized discharge planning, transportation from prisons to nonprofit service providers, and vocational, educational, and therapeutic services.

Data Note

The data in this report for LL34 reflects individuals who were enrolled in a MOCJ-funded Reentry program between July 2023 and June 2024. Rearrest data includes participants who completed their 6-month follow-up period during the reporting period, but may have been enrolled during the 6 months prior to the reporting period, to allow for a follow-up period.

Definitions

Clients Served: This data reflects individuals in the community that were enrolled in programming determined by date of intake. Demographics data reflects the client served population.

Job Placements: This data reflects individuals placed in paid employment.

Reuniting with his daughter, who had accompanied him to the office, Roland embarked on his journey towards societal reintegration. Affectionately referring to his daughter as his secretary, Roland found solace and support in her unwavering presence throughout his incarceration, ensuring he had all the necessary documentation for his reentry process.

Meeting with Ms. Sims to enroll in the Jails to Jobs program, Roland radiated excitement and eagerness to rejoin the workforce. Through the program, he received invaluable assistance with his Public Assistance application, along with essential items such as a cell phone, a dignity kit care bag, and a welcome home gift card. Roland's joy knew no bounds as he graciously shared his blessings with his daughter, placing her well-being above all else.

Securing temporary housing with his daughter, Roland wasted no time in seizing employment opportunities. Enrolling enthusiastically in Job Readiness Training (JRT), he polished his skills, crafted a professional resume, and received attire suitable for interviews. While respecting his daughter's space and aiming for independence, Roland sought additional assistance from the Fulton Community for housing services while actively pursuing employment.

Undeterred by obstacles, Roland persevered in his job search and eventually landed the Janitorial Maintenance position at Osborne Association Social Ventures. Receiving his first paycheck marked a significant milestone in his journey, prompting Roland to express profound gratitude to the staff and his case manager for their unwavering support. In his own words, Roland acknowledged the pivotal role they played in his success, stating, "I couldn't have done this without you all."

“Barin B.”

Youth Justice Network (YJN)

As told by a Youth Advocate:

“I met Barin B. over three years ago. I was new to the YJN team, and Barin was a part of the first group of participants I began to engage with back in April 2022. At this time, Barin was still incarcerated at Rikers, and as I did not have access to go on the Island yet, our first 3 meetings and those after for the first few months were strictly virtual via tele-visits. From our first, I knew he was a special young man, who had so much charisma and warmth to him. I remember we shared so many laughs, and even though I was a new face, Barin exuded so much comfort in someone being there for him.

After a few months, I was cleared for Rikers, and met Barin for the first time in person in July 2022. Until his discharge upstate the following year, August 2023, I met with Barin on a roughly biweekly basis with a mix of in person visits and tele-visits. During this time, Barin and I focused heavily on a mentoring relationship. It was a hard time for him; his future was still up in the air and out of his control and he struggled with it greatly. It was during this phase of our relationship that we really developed the close rapport we have now, and it was built with trust and consistency. It used to be a running joke that I would have to save my check-in with him for last when I was on Rikers, because I would always go over my 30 min limit, because with Blue it was always easy to do! When his case was finally concluded and he was sentenced upstate, our relationship evolved again, this time into pen pals while still providing support. Barin was upstate for nine months, and during that time, we wrote each other on JPAY monthly. With YJN as a major support to him, we were able to send him books through our Books to Jails program, as well as warm clothes/accessories during the winter months.

Throughout this time, Barin's only knowledge and experience of YJN was me. To have him connect and make his own bonds with so many of our staff has been so special to witness and be a part of, and has been the biggest blessing as his advocate. Barin has been home since April 2024, and hasn't taken his foot off the gas for a second. He has accomplished so much and yet still struggles with the barriers of reacclimating to society. Since being home, YJN has supported Barin with employment opportunities through our Career Center. He is currently under consideration for a part-time job with one of our partners, Mount Sinai Hospital. Additionally, we are supporting Barin with his identification barriers, most importantly, his birth certificate, which is on route from his home state of North Carolina. Most recently, Barin had the opportunity to participate in a youth-led symposium, hosted by CCA. Barin represented YJN as a youth member. It was his first opportunity to speak on his experience with YJN as well as participate in a youth panel discussing various youth justice topics. Barin was nervous and we prepped a lot for his first public speaking event, but to foster his growth, and voice, in this setting lit a light in him, and he wants to pursue a future as a youth mentor.

I am so immensely proud of Barin, I have known him through so many different phases of his life within these past 3 years, and I am looking forward to witnessing his bright future and continuing our work together.”

ATLAS

About Atlas Programs:

Atlas works to reduce cycles of violence and justice system involvement in New York City through community-based therapeutic and healing services. Launched in the middle of 2020, Atlas is the newest community-based violence prevention initiative of the Office of Neighborhood Safety. The program fills an early intervention gap by directing evidence-based therapeutic services to the small population of people most at-risk for engaging in or experiencing violence. Atlas makes free, transformative public health models available for people facing the crisis of a recent arrest or court case on a completely voluntary basis and offered through trusted community-based partners. The approaches are culturally competent, trauma-informed, and deeply respectful of the strength, wisdom, and personal agency that resides in people.

Most people come to Atlas after a recent arrest as a support mechanism to help them remain safely in the community while managing the challenges of an open court case. Referrals can come from anywhere, including defense attorneys, the Criminal Justice Agency (CJA), NYPD Youth Coordination Officers, and other community-based non-profits. Atlas services are always free to participants and are accessible through community-based organizations that prioritize the cultural and holistic well-being of people who have had negative experiences with interpersonal violence and punitive systems. As a community-based response to public safety and well-being, Atlas services are not connected to the court process and people remain eligible even after their case has been resolved.

Data Note

The data in this report for LL34 reflects individuals who were enrolled in Atlas between July 2023 and June 2024. Rearrest data is defined as the young adults referred to Atlas by the Criminal Justice Agency (CJA), whose eligibility was determined at an arraignment event, who started FFT as part of Atlas in fiscal year 2023 to allow for a follow-up period for rearrest. Atlas is a voluntary program and is not mandated by the court

Definitions

Clients Served: This data reflects individuals in the community that were enrolled in programming determined by date of intake. Demographics data reflects the client served population.

Felony Rearrest: Felony rearrest is defined as pretrial rearrest where the pretrial period is connected to the arraignment that defined the participant's eligibility.

Looking Forward: Expanding Program Evaluation and Quality Assurance Capacity at MOCJ

The Mayor's Office of Criminal Justice (MOCJ) is committed to enhancing its program evaluation and quality assurance capacity to boost the effectiveness of services. The strategic plan for infrastructure development outlines MOCJ's future initiatives, focusing on three core areas: advancing data infrastructure, strengthening quality assurance, and refining operational systems. These efforts aim to elevate program quality through rigorous evaluations, ensuring alignment with goals and improved outcomes.

1. Data Infrastructure Development

Objective: Enhance data capabilities to provide precise insights into service delivery and improve outcomes.

Current Status: MOCJ has made substantial progress in building its data infrastructure, yielding valuable insights for better service matching, especially for vulnerable and underserved populations, allowing for more precise allocation of resources to deliver the largest public safety and quality of life impacts. However, current recidivism metrics are often limited by gaps in data, variability in participant risk and needs, and the lack of robust comparison groups.

Action Steps:

- **Expand Data Definitions:** Develop comprehensive metrics that capture diverse success indicators, including various recidivism definitions and alternative success measures.
- **Improve Comparative Analysis:** Expand the use of advanced analytic developmental evaluation tools to compare outcomes with scientifically rigorous benchmarks, refining service matching and addressing justice service gaps.
- **Enhance Data Robustness:** Invest in interagency collaboration to strengthen data quality and provide clearer insights for more effective service matching.

2. Quality Assurance

Objective: Fortify internal and external quality assessment processes.

Current Status: While internal metrics and qualitative reporting are in place, MOCJ has laid the foundation for more robust evaluation methods. The investment in cutting-edge, evidence-based, and trauma-informed quality assurance infrastructure aims to support enhanced program effectiveness and foster improved justice outcomes.

Action Steps:

- **Implement Evidence-Based QA Assessments:** Rigorous assessment data and field metrics regarding the quality of service delivery will be conducted across a

range of domains, including leadership and staff development, programming, evidence-based engagement and retention strategies, trauma-informed care, and clinical service delivery.

- **Provide Quality Technical Assistance:** Collaborate with external experts to offer training and support, enhancing program effectiveness.
- **Establish Feedback Mechanisms:** Integrate evaluation feedback into program improvements and investments to drive continuous enhancement.

3. Operational Infrastructure Development

Objective: Refine and expand the operational system to improve service matching and effectiveness.

Current Status: The operational service connection system at the Criminal Justice Agency (CJA), demonstrated through projects like Atlas and Supervised Release, has shown enormous potential to deliver high quality services to people at the most elevated need. In addition, the city-funded Case Review initiative at CJI has produced tremendous insights in better addressing the needs of participants who remain in jail due to logistical barriers to appropriate matching to services. Plans are underway to scale and refine these systems to address service gaps more effectively.

Action Steps:

- **Scale Operational System:** Enhance the system's capacity to accommodate a broader range of services and participants, based on precise needs and identified service gaps.
- **Expand Clinical Needs Assessment Infrastructure:** Ensure assessment capacity and court support to reduce delays due to logistical barriers.
- **Ongoing Evaluation:** Continuously assess and refine the system using performance data to improve service matching and coordination.

Conclusion

MOCJ's strategic focus on expanding data infrastructure, enhancing quality assurance, and refining operational systems is designed to improve program effectiveness and service delivery. By advancing these initiatives over the next two years, MOCJ aims to achieve significant advancements in criminal justice reform, ensuring better outcomes and more effective support for individuals in the justice system.
